This is because these categories of family members are the closest one to the deceased and I am sure they have every right to get the residuary estate of the testator. According to Roscoe Pound, there are two components into its definition of law which are law is a means of alleviating conflict through the imposition of organized force and law functions to secure the realization of as many individual interests as possible. I believe the solution to the partial intestacy case where it will be referred to law of intestate is made based on the second definition of law in sociology theory which is that laws function to secure the realization of as many individual interests as possible because as a normal person, I believe many people want to give their properties to their immediate family members when they die. Maybe there are some individuals that want to give their property to other than their family member, however back to the definition of law under sociology theory it functions to fulfill as many individuals' interest as possible. Thus, I believe that the reason for not having specific law on partial intestacy is because it is better to apply law of intestate to the case of partial intestacy as many people would agree that the residuary estate to be distributed to the immediate family members of the testator. If I have a chance to do the service learning again, I would like to do it physically and virtually. I would like to conduct some talks with the public to spread awareness on partial intestacy because by delivering the
